This Agreement is made and entered into on this **30st day of June, 2025**, by and between:

Jigsaw Edu Solutions Pvt. Ltd., having its registered office at Rani Bagh, Pitampura, hereinafter referred to as "**Jigsaw**",
AND DAV Police Public School Sonipat, Haryana, located at **Sonipat**, here in after referred to as "**School**".

Collectively referred to as the "Parties".

1. Purpose

This agreement is made to outline the terms and conditions under which Jigsaw will conduct educational classes for **Abacus** and **Vedic Mathematics** at DAV Police Public School Palwal

2. Program Details

- **Activities Offered:** Abacus and Vedic Mathematics

3. Student Enrolment and Teacher Allocation

- **Jigsaw will be providing teachers.**

4. Payment Terms

- The **total fee per student** for the entire program is **₹2750**.
- The payment shall be made by the School to Jigsaw as follows:
 - **100% advance payment** before the start of classes.
- All payments shall be made to Jigsaw Edu Solutions Pvt. Ltd. through cheque or bank transfer.

5. Responsibilities of Jigsaw

- Provide trained and qualified instructors for all activities.
- Ensure smooth and regular conduct of scheduled classes.
- Maintain attendance and performance records of enrolled students.
- Teaching materials and resources, where applicable.
- **Jigsaw's instructors shall visit the school once every quarter to conduct an internal audit to ensure the quality and effectiveness of the classes.**

6. Responsibilities of the School

- Provide suitable space and infrastructure for conducting classes.
- Facilitate communication between Jigsaw instructors and school staff.
- Share student data required for enrolment and reporting purposes.
- Support in implementing the schedule and maintaining discipline during sessions.

7. Term and Termination

- This agreement shall be valid from **01-july-2025** and shall remain in effect until the end of the academic session.
- Either party may terminate this agreement by giving **30 days' written notice**, provided all financial and operational obligations till the date of termination are fulfilled.

8. Dispute Resolution

- Any disputes arising out of this agreement shall be resolved amicably through discussion.
- If not resolved, the matter shall be referred to arbitration under the Indian Arbitration and Conciliation Act, and the decision of the arbitrator shall be final.
- The jurisdiction for legal matters shall be the courts of Delhi.

9. Entire Agreement

This agreement represents the full understanding between the parties and supersedes all prior discussions or written communications.
